WHEREAS, by that certain Right of Way Contract dated April 2, 1956, recorded in the Records of Pierce County, Washington, in Volume 1110, Page 841, the Brew Manufacturing Company, a Washington Corporation, as Grantor, granted and conveyed unto Pacific Northwest Pipeline Corporation, a Delaware corporation, its successors and assigns, a right of way and easement to construct, maintain and operate a pipeline or pipelines on a right of way over and across the following described lands situated in Pierce County, Washington to wit:

WHEREAS, El Paso Natural Gas Company, a Delaware corporation, hereinafter referred to as Grantee, is the successor in interest to Pacific Northwest Pipeline Corporation, and;

WHEREAS, the undersigned Grantors are now the owners of the above described property and;

WHEREAS, the Grantors and Grantee desire to, and have agreed to amend said Right of Way Contract.

NOW THEREFORE, for and in consideration of Ten Dollars (\$10.00) and other consideration paid to the Grantors by the Grantee herein, the receipt of which is hereby acknowledged, the Grantors and Grantee do hereby amend said Right of Way Contract to provide as follows:

- The right of way referred to above shall be sixty (60) feet in width over and across the above described land and is more particularly described by survey line as follows:

A strip of land 60.0 feet wide being 20 feet westerly and 40 feet easterly of a survey line across the E $\frac{1}{2}$ SE $\frac{1}{4}$, SE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 3, Township 19 North, Range 4 East, W.M.) Pierce County, Washington, the survey line being more particularly described as follows:

Beginning at a point on the West boundary of said E $\frac{1}{2}$ SE $\frac{1}{4}$, Section 3, said point bears North 41° 12' East, a distance of 1970.8 feet from a nail for the south quarter corner of said Section 3, thence North 43° 47' East, a distance of 1835.4 feet to a point on the East boundary of said Section 3, said point bears North 42° 27' East, a distance of 3805.2 feet, from said south quarter corner of said Section 3.

2. El Paso Natural Gas Company shall have the temporary right to use a strip of land fifteen (15) feet wide, parallel and adjacent to and easterly of the easterly margin of said permanent right of way, for the purpose of and during the construction, installation, and testing of its second pipeline, but said temporary right shall in any event, expire and all of El Paso Natural Gas Company's rights therein shall terminate on December 31, 1972.

Said Right of Way Contract, as hereby amended, shall be binding upon the parties hereto, their heirs, successors and assigns.

Except as hereby amended all terms and provisions of said Right of Way Contract are continued in full force and effect.
