Purpose of checklist

A Phase I ESA has been prepared for this proposal. No evidence of a recognized environmental condition was found and no further assessment was recommended.

The applicant has applied for a Building Permit and a Civil Permit for construction of proposed improvements following the demolition of the existing building.

A Construction Stormwater Notice of Intent (NOI) with the Department of Ecology will be applied for at a later date.

The project proposes the demolition of one existing building and associated parking areas and utility services.

The building area and parking lot are relatively flat (2 - 3% slopes), with a rockery retaining wall on the east side and a concrete retaining wall on the west side.

b. What is the steepest slope on the site (approximate percent slope)?

The rockery is stabilizing an approximately 80% slope. The landscaped areas have a maximum slope of approximately 30%.

c. What general types of soils are found on the site (for example, clay, sand, gravel, peat, muck)? If you know the classification of agricultural soils, specify them, and note any agricultural land of long-term commercial significance and whether the proposal results in removing any of these soils.

Silty Sand with Gravel and Silty Gravel with Sand were the primary soil types identified in the borings from the geotechnical report. No agricultural soils were identified.

The geotechnical report did not identify any indications or history of unstable soils on the site or in the immediate vicinity.

- e. Describe the purpose, type, total area, and approximate quantities and total affected area of any filling, excavation, and grading proposed. Indicate source of fill.**

The scope of work associated with this SEPA application will be limited to demolition of the existing building, existing onsite pavement, and existing onsite utility services. Earthwork associated with the removal of existing utility services is approximately 300CYD which will be exported and disposed of offsite.

- f. Could erosion occur because of clearing, construction, or use? If so, generally describe.**

Grading activities and rain events during construction may cause erosion. All erosion will be minimized to the greatest extent possible by implementing measures satisfying City erosion control requirements to protect the disturbed areas and minimize erosion leaving the project area.

- g. About what percent of the site will be covered with impervious surfaces after project construction (for example, asphalt or buildings)?**

The scope of work associated with this SEPA application will be limited to demolition of the existing building and all existing onsite pavement. 0% of the site will be covered with impervious surfaces after project construction.

h. Proposed measures to reduce or control erosion, or other impacts to the earth, if any.

A temporary erosion control plan will be designed per City standards to include approved Best Management Practices (BMPs). The BMPs will be installed to reduce and control erosion during the construction of the project. The project anticipates a silt fence is proposed around the entirety of the disturbed area, a temporary sediment pond to allow for construction stormwater settlement, and a construction entrance to reduce construction equipment tracking soil offsite.

The scope of work associated with this SEPA application will be limited to demolition of the existing building. Operational and maintenance emissions are associated with the proposed onsite improvements that are not under review by this SEPA application. During construction: dust, concrete batching, asphalt installation, painting, construction equipment emissions.

The applicant is not aware of any off-site sources of emissions or odor that may affect the proposal.

Construction equipment will meet state and local emissions standards. Permanent stabilization of the site will be achieved prior to construction completion.

Neither septic tanks nor any other waste material discharge into the ground is proposed.

Stormwater that leaves the site will drain to an existing manhole at the SE corner of the site and enter an existing stormwater main. The proposed onsite improvements and associated stormwater management are not under review by this SEPA application.

Waste materials will be prevented from entering ground or surface waters to the maximum extent feasible through the use of erosion control measures.

The proposal is limited to demolition of the existing building and will not alter onsite drainage patterns. The proposed onsite improvements and associated stormwater management are not under review by this SEPA application.

The project will implement erosion control BMPs to manage construction stormwater runoff.
